The redemption amount of the Notes (being at least equal to 100% of the Calculation Amount) depends on the evolution of the Underlying Reference being the Solactive Sustainable Goals Europe MV Index (SOLEGOAL Index), as specified under Part A, with a potential amount above the par value (paid at maturity).

The Solactive Sustainable Goals Europe MV Index is an Index of Solactive AG and is calculated and distributed by this provider. The Index is designed to track the performance of European companies with a comparably high dividend yield and, at the same time, construct a portfolio which exhibits low volatility and avoids excesses sector concentration. The Index is published in Euro and is based on 100 at the close of trading on the start date of 20 April 2001. The Index is published via the price marketing service of Boerse Stuttgart AG.
