The risk of an inadequately-controlled rise in long-term interest rates may in particular be emphasised, under the scenario of an unexpected increase in inflation or an unanticipated tightening of monetary policies. This is particularly the case for the United States and certain European countries (in particular Greece, Italy and Portugal) which are often posting public debt-to-GDP ratios above 100%, but also for emerging countries. Between 2008 and 2017, emerging countries recorded a marked increase in their debt, including foreign currency debt owed to foreign creditors.</p> <p data-bbox="719 792 1445 1274">The private sector was the main source of the increase in this debt and to a lesser extent the public sector, particularly in Africa.
